The objective of the camp is to spread awareness about human rights among the general public of the area and to create awareness on various areas like women rights, child rights etc. The way awareness of the topic was shown among the attendees and the simple language given by the resource persons. The topic has been explained in detail to the general public and the positive energy generated is a testament to the success of the camp. program implementation

The program was organized by the organization in 4 parts. Each part was conducted in the presence of the invited people and also the invited resource person gave topic-wise information to the people present.

The details of the session program are as follows

Registration

Start of the program 9.30. It was done at but the contestants came before time and created enthusiasm among the workers of the organization. According to time . All attendees were registered from 9.30 to 10.00

Session-I

Advocate Sanjeev Kumar Choudhary was invited for the first session. Choudhary ji is a professional lawyer and also works as a legal advisor to the people of the area. Advocate Mr. Sanjeev Kumar Choudhary told about the constitutional provisions of human rights. Besides, people were also told in detail about the Universal Declaration on Human Rights 1948. In his last session, Shri Sanjeev Kumar Choudhary also gave detailed information about international contracts regarding human rights.

At the end of his address, Advocate Shri Sanjeev Kumar Choudhary concluded the session by giving satisfactory answers to the questions raised by the aware people.
